## The Center for Cultural Innovation Announces Grants to 24 California Performing Arts and Media Arts Artists

The Center for Cultural Innovation (CCI) today announced twenty-four recipients in the Performing Arts and Media Arts round of funding under its *Investing in Artists* grants program, which is designed to build the personal and creative capacity of California's artists working in all disciplines.

The *Investing in Artists* grants program was established by CCI in 2007 to enhance the working lives and strengthen the creative support system for California artists. Since that time, with the support of The James Irvine Foundation and The William and Flora Hewlett Foundation, CCI has awarded \$1.8 million to 250 diverse artists working in various disciplines across the state.

The 2014 Performing Arts and Media Arts Round of the *Investing in Artists* grants program provides support to individual artists in two categories: 1) for the acquisition of Artistic Equipment & Tools; and 2) for Artistic Innovation.
